## Minutes Of Brechin Diocesan Synod Held Saturday 4<sup>th</sup> March 2023 at St Mary's Broughty Ferry

#### **Synod Opening Eucharist**

The Bishop celebrated the eucharist and gave the Charge:

Greetings and a warm welcome to the Diocese of Brechin Synod for Spring 2023. We meet again here in Broughty Ferry, for this business meeting of the Diocese: and the business we conduct is always important. This year is no different: the liturgies and laws of the Church change: we have part to play in that. We have a role to play in the boards and committees that make the life of the whole SEC and this Diocese function. And the environmental crisis and our part as a church in responding to that is back on our agenda again. All very important things!

But does all that feel important out in our churches, in the communities we serve? What is God calling us to be in all the places we serve, from the Cathedral in Dundee, to the community out west in Glencarse and to the church up in Muchalls, to the north? What need are we meeting?

The gospel reading we just heard is the one set for the day, from the Gospel of St Matthew, the Sermon on the Mount. Jesus is calling his followers, his disciples, to a radical way of living. Loving your enemies, praying for those who persecute you: he is giving us a radical new way of showing God's love for the whole world.

In a world where war still rages in Ukraine and so many other places, where the curses of poverty and disease still challenge so many people worldwide as well as this country, and where the environmental crisis is threatening so many of the world's vulnerable people: there is a mission for us, as churches, set in our diverse communities. We are called to be signs of God's grace and love: whether we are a large or a small church community, whether we are growing or declining, how we relate to those around us, how we work to support the weak and vulnerable: that starts to look like maybe even loving those we might fear to be enemies!

So back to this Synod: the business the Canon law (how we elect bishops this year), the boards and committees, the diocesan structures: all that enables and supports the lives of each and every church community in the care of this diocese. The province and the Diocese are there to support the clergy and the people of each and every community in this Diocese. There have been problems in recent Episcopal elections – the canon aims to improve matters.

There are difficulties in our neighbouring diocese in the north: the Provincial structures are here to handle such difficulties. The environmental work we will discuss today is to guide and support us to make changes that will help the SEC in its response to the ecological crisis. All the work we do today is to help, guide and support our church communities to be those signs of God's grace and love.

So I thank you for coming to meet today, and I pray God's spirit will guide our deliberations and decisions. May this be a blessed time of gathering and growth.

## Session 1 - Mission and Ministry Reports and Canonical Revision

#### 1.1 Opening Business

Apologies were received from Rev'd Mary Jepp and Rev'd Jim Benton-Evans and from the Lay Reps from Laurencekirk and Drumtochty.

Tellers: Dr Aileen Black and Rev'd Canon Kenneth Gibson were appointed tellers.

Roll call: 50 members of Synod were present and registered as they signed in on arrival.

New attendees: There were fewer changes in clergy this year.

Rev'd Roxanne Campbell is attending in a different role as interim priest at St Martin's, Dundee and Priest for Outreach at the Cathedral.

It was also the first Synod for Mrs Betty Paterson St Andrew's Brechin and Mrs Deborah McDonald St Mary's, Arbroath.

<u>In memoriam</u>: The Rt Rev'd Ted Luscombe former Primus and Bishop of Brechin.

<u>Companion Links</u>: Canon Pat Millar had submitted the Companion Links report before the All Saints 'Hymnathon' had taken place. It raised £5.000. There is no upper limit and there is still an opportunity to make contribution.

Video Greetings were received from Bishop Betsey of Iowa and Bishop Dalcy of Swaziland. Both bishops recalled the pleasure they felt at being in Brechin after Lambeth last year. Bishop Betsey prayed for the work we are doing and is looking forward to welcoming +Andrew to the 3<sup>rd</sup> stage of the Youth Pilgrimage in August. Bishop Dalcy sent her best wishes and love and greetings. The Bishop observed that link between the three dioceses had been going for 40 years and he sent the greetings of Synod to both Iowa and Swaziland.

#### 1.3 Business from General Synod 2022: Canonical Revision

#### Revision of Canon 4: Of the Election of Bishops to Vacant Sees

A presentation was given by Dean Fay. An extensive discussion took place, which has been distilled into the following notes to be fed back to the General Synod:

Culture for Discerning for Bishops

Clearly stated criteria should be offered for those considering Episcopal ministry: so that candidates that are NOT suitable for such ministry can self-assess and/or be objectively addressed.

Diversity: these criteria for Episcopal ministry should be offered to encourage diversity of characteristics (any/all of these) for candidates (noting the not terribly diverse College at present maybe not actively encourage diversity: "I don't look/think/act like a Bishop so I cannot be a Bishop...").

This diversity of candidates (and Bishops) should be actively monitored by the bodies running the electoral process/the Province.

Request that the training produced for those involved in the process include unconscious bias training.

Stronger emphasis on pastoral care for those candidates who are not elected to Episcopal ministry.

Role of the College of Bishops / Episcopal Synod

Request for clear and transparent criteria that the College would use for judging whether College Assent might be withheld. If a candidate were not given this assent, the reasons for this should be made clear to them.

Concern over the 'Assent of the College of Bishops' stage rejecting candidates, resulting in an otherwise quorate shortlist being reduced to two or one and making the process 'fail' at that stage. Suggestion that this should not be permitted.

If Stage 2 fails because the shortlist became one, that candidate should go into the Episcopal Synod discernment process.

If Stage 3 is entered, ensure that the Episcopal Synod will base their election on the stated needs/values of the Diocese in the Description of the Diocese and Role Description.

Propose a strengthened process to connect the Diocese when the Episcopal Synod elects a candidate in Stage 3. More than the Preparatory Committee: maybe a ratification vote by the Electoral Synod to confirm sufficient Diocesan support for the candidate.

The amended Canon was then put to the Synod for the advisory vote in houses:

#### **Session 2 : Council Reports and Environmental Matters**

#### 2.1 Council Reports

The following reports were received as read:

No questions on any reports other than Diocesan Buildings Committee report.

It was suggested that a Budget be given to the DBC otherwise it cannot function eg. could assist with net zero.

Dean Fay responded that the DBC was essentially an advisory committee. Net zero is an entirely different matter and having a DBC budget should be resisted.

She advised that all charges should read the criteria on the diocesan website before making any application.

## 2.2 Provincial Environmental Group - Net Zero Update

A presentation from PEG was given by Miriam Weibye.

Net Zero Action Plan for Diocesan Synods 2023.

The Provincial Environment Group has just released the Net Zero Action Plan 2023-2030 in draft form as part of the consultation process that is underway. It seeks to show synods how it can help to contribute to a flourishing, hope-filled future for all charges in this diocese. The document, Net Zero Action Plane 2023-2030, is <u>not</u> a document for those charges just starting out. The best resource for churches to tackle climate change is the Net Zero Toolkit.

The draft Action Plan is now on the SEC website.

- We are realising the 5<sup>th</sup> mark of mission "to strive to safeguard the integrity and creation, and sustain and renew the life of the earth"
- Churches that are resilient places of warm welcome
- The land is rich in biodiversity
- We are a zero waste church
- We are a climate literate church
- Our worship is rooted
- We have a prudent but holistic approach to financial management
- We are part of a broader movement of change
- Maintain a credible voice for justice in the world
- We are beacons of hope in action

In order to categorise the various emissions of the church, we are making use of the Greenhouse Gas Protocol, an international standard used by most organisations, which divides emissions into three main scopes.

- Scope 1 emissions are all direct emissions arising from onsite generation of energy in our buildings, vehicles or land. This will be mainly the oil and gas boilers used to heat our churches and halls.
- Scope 2 emissions are the indirect emissions associated with the use of electricity, heat, steam and/or cooling. In most cases this will be mainly be from the electricity supplied to the national grid.
- Scope 3 emissions are all other indirect emissions that occur in the church's 'supply chain' in other words the purchased goods and services the church uses, its waste water use as well as work-related travel.

For Net Zero 20230 target, we intend to use all Scope 1 and 2 emissions, and reimbursable travel from Scope 3.

## Net Zero 2030: Boundary

"All those entities that are within the sphere of SEC that are under its control or significantly under its influence". That means all cathedrals, churches, church halls, clergy and bishop housing, all offices and the Scottish Episcopal Institute.

The intent in setting this boundary as well as scopes of activities included, is to balance the prophetic motion of General Synod 2020 to reach net zero by 2023 with what is practical and possible. In doing so we believe this definition encompasses the material emissions of the church, ensuring the plan is both credible and robust.

#### Ten strategic principles:

- First is the fundamental moral imperative for the church to act.
- Second is that our approach must be Ecologically sound
- Third that solutions proposed are Technically realistic
- Fourth is to be financially prudent.
- Fifth is to protect the heritage of our buildings
- Sixth, the whole net zero 2030 plan is result-driven
- Seventh, to ensure that the strategy increases provincial and diocese cross-committee collaboration
- Eighth to cultivate an ecosystem of partnerships
- Ninth to be based on a credible approach to reducing carbon emissions
- Tenth to take a systems perspective

#### Ten objectives

- 1. Energy Efficiency Excellence
- 2. 100% Clean Energy
- 3. Thriving Biodiversity
- 4. Active transport
- 5. Zero Waste
- 6. Ensuring Good Governance
- 7. Climate Literate
- 8. Rooted Worship
- 9. Positive Finances
- 10. Build a movement

#### **Provincial & Diocesan Resourcing**

Appointment of a Net Zero Delivery Director by GSO.

Cross-diocesan Net Zero Working Group for the Province.

Diocesan Environmental Working Group in each Diocese.

PEG is recommending to the provincial Standing Committee that a new, dedicated full-time Net Zero Delivery Manager is recruited in every diocese, with the province using its financial reserves to cofund this position on a 50/50 basis with each diocese.

#### **Discussion**

Synod broke into small groups to discuss the presentation and ask questions.

Comments included: are we putting the cart before the horse? How should we 'be' church? Can each diocese afford a Delivery manager? Answer: This could be shared with another diocese.

Questions of the shared position with listing buildings and energy efficiency changes with e.g. Church of Scotland and dealing with e.g. Historic Environment Scotland.

Question: is the £27 million available for energy efficiency from Government grants actually realistic? Answer: The funds  $\underline{do}$  exist. For every £1 invested it is anticipated that 10 times can be received in grant funding.

Young people do realise the priorities but we do need to understand young people's fears on environmental issues.

The Bishop expressed Synod's thanks to Miriam for her presentation and the work of PEG is guiding the SEC in the work towards Net Zero..

The Synod broke for lunch.

#### Session 3: Governance and Finance

#### 3.1 Finance

The Diocesan Treasurer gave a report on the past year.

The accounts are now with the auditor and more details will be given at the Autumn Synod. The 'high' of the year is that the accounts are on an cloud-based Sage system; the 'low' was the challenge and difficulty of having bank account signatories transferred. It has taken from August 2022 until February 2023 to be resolved.

The balance is more or less as expected. The new quota system gives a year's lag reducing pressure on Vestry Treasurers. In response to a question, a longer time lag (maybe 5 years) instead of 3 year <u>is</u> possible in setting quota, but quota will be on the agenda at the Autumn Synod.

The Bishop thanked both the current and the former Treasurer, Allan Duffus.

#### 3.2 Cathedral Statutes

The Cathedral statutes are the rules that govern the Chapter and the life of the cathedral as the bishop's seat: the congregation of the cathedral have a charity constitution. The process for changing the statutes is that the Chapter initiates any change, which is passed to the Diocesan Synod for approval, then finally requires approval from the Episcopal Synod, the College of Bishops sitting in Synod.

The Stautes were last updated in 1961 and 1982 but are largely unchanged since 1905 when St Paul's became the Cathedral of the Diocese.

The Current Statutes dated 1982 and the Proposed Statutes for 2023 are included in the Synod papers.

The proposal is not limited to the current composition of Canons but introduces other modern categories – ecumenical and lay. As well as the Dean and Provost, Dean Emeritus and Provost Emeritus are included and also assistant clergy as 'minor' canons.

Comments were invited. Provost Elizabeth reported that the Vestry had been informed of the proposals and seemed happy with them. This change has also been an opportunity to introduce material on the definition of the cathedral's mission: work in the city and the diocese.

Comment: the text has used 'he or she' to refer to the Provost or Bishop – this is clumsy drafting; 'they' would be better English. There was some debate whether this was about pronouns and non-binary language – it is not, but rather just better English.

Comment: The cathedral is not accessible to all but Provost Elizabeth suggested that mission work in the city (the city council) reinforces the link in ultimately achieving disabled access.

The proposal to amend the text of the revised statutes to change 'he or she' to 'they' in various places was accepted. The revised statutes were then put to the Synod for approval.

For the day, Rev Roxanne Campbell was thanked for arranging the liturgy, Elliott Scarfe was thanked for admin and organisation and all were thanked for attending.

Dean Fay expressed her thanks to Bishop Andrew for his conduct of the Synod.

#### Confirmation of Acts of Synod

#### **Dates of future Synods**

The revised Cathedral statutes were approved in March 2023, to be passed to the next Episcopal Synod for final approval. The Episcopal Synod has not yet met (it meets in November 2023), but some issues in the Province have raised the issue that, under Canon 10.3, a breach of any of Cathedral Statutes may be treated as breach of the Code of Canons, which is a disciplinary offence under Canon 54.2(c): "knowing violation of the Code of Canons or of anything lawfully ordered thereunder." The newly inserted parts of the statutes that discuss the vision and mission of the cathedral risk a problem in this area: if a disagreement arose as to the mission/vision priorities of the cathedral, a Provost or other members of the chapter might find themselves at risk of prosecution for misconduct. The simple solution to this risk is to remove the 'mission/vision' text from the statutes and to place it in another document that does not form part of the totality of the Code of Canons. The amendment today is to delete sections '1 – The Cathedral', '3.4' and to renumber the sections to deal with these changes. No other changes are proposed.

As such the Cathedral shall  1.2.1.maintain a regular pattern of prayer and worship, giving glory to God and holding before God the needs of the church and the world, and particularly of the Diocese of Brechin and the civic administrative areas within the boundaries of the said Diocese;  1.2.2.be a focus for the ministry of the Bishop of Brechin, a resource to the Bishop and a place where prayer is offered for the Bishop and the Diocese;  1.2.3.preach the Gospel of Christ and nurture Christian learning, in collaboration with other churches and traditions and with sensitivity to other faiths;  1.2.4.extend hospitality to pilgrims and visitors of every kind;  1.2.5.demonstrate the concern of Christ for the poor;  1.2.6.engage with civic and corporate life and institutions in the complexities of contemporary society and culture, and explore spiritual values with all people of goodwill;  1.2.7.share with and be a resource to the churches of the Diocese of Brechin in every aspect of the Church's vocation.

#### Of the Bishop

The Bishop shall be the head of the Cathedral Church and its Visitor, whose decisions as such shall be final, subject to an appeal to the Episcopal Synod.

He shall take such part in Divine Service and shall, after due notice, preach, at such times as he shall determine, and he may appoint occasional or special preachers.

He shall have the use of the Cathedral Church for any Episcopal Acts or Special Services, or Diocesan Functions, provided by the Statutory Services be not interrupted, expect with the concurrence of the Rector and Chapter.

He shall personally, or by deputy, install the Canons and receive their declaration of obedience to the Statutes and Bye-Laws.

#### 2. The Bishop

- 2.1. Under the Bishop, the Cathedral shall be governed in accordance with its Statutes.
- 2.2. The Bishop shall be the head of the Cathedral. As head:
  - 2.2.1.The Bishop shall have the principal seat and dignity in the Cathedral;
  - 2.2.2.The Bishop shall have the use of the Cathedral for all episcopal acts and diocesan functions, provided that the statutory services be not interrupted except with the concurrence of the Provost. On any such occasion, the Bishop may determine the ordering thereof, after consultation with the Provost, and may preach or appoint the preacher;
  - 2.2.3. The Bishop shall have the right, provided that not less than four weeks' notice of the intention be given, to preside and to preach at the Holy Communion on any principal feast;
  - 2.2.4. When the Bishop is present at the celebration of the Holy Communion or of Holy Baptism in the Cathedral, having given notice of their intention to be present, the Bishop shall normally be the president of the rite. At any service at which the Bishop is present, they shall normally pronounce the blessing.
- 2.3. The Bishop shall personally, or by deputy, install the Canons and receive their declaration of obedience to the Statutes and Bye-Laws.

#### Of the Rector and Provost

The Rector shall be appointed in the manner provided for in Article 19 of the Constitution of the Cathedral Church of Saint Paul, Dundee, a copy of which Constitution is annexed hereto. He shall be instituted and installed by the Bishop. He shall be Provost of the Cathedral Church, unless that office has been assumed by the Bishop.

He shall rank next to the Bishop in the Cathedral Church, and under him and with his concurrence shall govern it and control the performance of all Divine Offices.

On any vacancy occurring in the office of Provost, the Bishop may, at his discretion, assume and hold office.

[Removes the option for a Rector to be appointed who is NOT the Provost]

#### 3. The Provost

- 3.1. The Rector of the Church of St Paul in Dundee shall be appointed in the manner provided for in Article 20 of the Constitution of the Cathedral Church of Saint Paul, Dundee, a copy of which Constitution is annexed hereto. She or he shall be instituted and installed as Rector by the Bishop.
- 3.2. The Rector shall be Provost of the Cathedral Church.
- 3.3. The Provost shall be the principal dignitary of the Cathedral, next after the Bishop.
- 3.4. Under the Bishop and with the Bishop's concurrence, the Provost shall govern and direct the life and work of the Cathedral and in particular, shall:
  - 3.4.1.promote the mission of the church and the ministry of the Cathedral in the Diocese of Brechin and the civic administrative areas within the boundaries of the said Diocese;
  - 3.4.2.be present at the daily worship of the Cathedral on a regular and frequent basis;
  - 3.4.3.ensure that divine service is duly performed in the Cathedral with liturgical and music provision suitable to every occasion;
  - 3.4.4.ensure that the Statutes are faithfully observed;
  - 3.4.5.maintain good order and proper reverence in the Cathedral;
  - 3.4.6.fulfil the duties of the Rector according to the Constitution of the Cathedral Church of St Paul.
- 3.5. The Provost shall cease to be Provost on their resignation, retirement or dismissal as Rector.

## Of the Chapter

The Chapter shall consist of :-

The rector of Saint Paul's and four other Canons who shall be:-

- (a) The Dean of the Diocese ex officio
- (b) The Synod Clerk ex officio
- (c) Two instituted or licensed Presbyters in the Diocese, appointed by the Bishop.

The Chapter is recognised as the Council of the Bishop in all matters connected with the exercise of his office in the Diocese.

#### Of the Canons of the Cathedral

In the Cathedral Services, after the Rector or Provost, the Dean of the Diocese shall rank first, the Synod Clerk second, and the other Canons shall rank according to the date of their appointment as Canons.

## Of Resignations and Discipline

If the Provost or any of the Canons shall desire to resign his office, he shall give in his resignation, in writing, to the Bishop, or during the vacancy of the See, to the Primus. If the Provost or any Canon shall become permanently disqualified for the performance of the duties of his office, and incapable of sending in a valid resignation, a legal certificate to that effect under the hangs of two medical men, delivered to the Bishop shall be accounted as in all respects equivalent to a resignation. If any member of the Chapter shall cease to reside in the Diocese, or shall be sentenced to suspension or deprivation after Canonical trial, his appointment shall be, ipso facto, vacant.

#### Of Chapter Meetings

The Bishop shall summon and hold Meetings of the Chapter at his discretion or on a written request from the Provost or Rector, or from two of the Canons. Three to form quorum. In the absence of the Bishop the Dean of the Diocese shall preside, and failing him, the Provost, or, if the Bishop be Provost, the Rector. The Chapter shall elect a Chapter Clerk, who may be layman.

#### 4. The Chapter

- 4.1. The Chapter shall consist of the Provost and four Canons who shall be:
  - 4.1.1.The Dean of the Diocese ex officio
  - 4.1.2.The Synod Clerk of the Diocese ex officio
  - 4.1.3.Two instituted or licensed Presbyters in the Diocese, appointed by the Bishop to hold office as Canons for a term of five years, renewable by mutual consent.
- 4.2. On the death, resignation or dismissal of any of the Members of Chapter, their Canonries shall end.
- 4.3. The Chapter shall advise the Bishop in matters connected with the exercise of the Bishop's office in the Diocese.
- 4.4. In the Cathedral Services, after the Provost, the Dean of the Diocese shall rank first, the Synod Clerk second, and the other Canons shall rank according to the date of their appointment as Canons.
- 4.5. The Bishop shall summon and hold meetings of the Chapter at their discretion or on a written request from two Members of Chapter. At meetings of the Chapter, three persons shall be a quorum. In the absence of the Bishop the Dean of the Diocese shall preside, and failing the Dean, the Provost.
- 4.6. The Chapter may elect a Chapter Clerk, who may be a lay person.

Of Honorary Canons	5. The Honorary Canons
Members of the Chapter when retired from office may be appointed by the Bishop as Honorary Canons; in addition to such appointments the Bishop may appoint not more than four Honorary Canons, which dignity shall not normally be conferred upon Priests serving in the Diocese, but shall be regarded as a mark of esteem and honour for those who have served the Diocese faithfully, and who have either removed to another Diocese or retired from the active ministry.	<ul> <li>5.1. In consultation with the Chapter, the Bishop may appoint as Honorary Canons, as a mark of esteem and honour and in recognition of their service to the Diocese:</li> <li>5.1.1.Priests who have served as members of the Chapter when retired from active ministry; and</li> <li>5.1.2.Priests who have served in the Diocese when retired from active ministry; and</li> <li>5.1.3.lay persons who have served the Diocese when retired from active service; and</li> <li>5.1.4.lay or ordained representatives of the Diocese of Brechin's</li> </ul>
[Expansion of scope for honorary canons: 21st century use of canonries, Anglican Communion, ecumenism etc.]	Companion Dioceses <sup>2</sup> in the Anglican Communion while in active ministry in their Dioceses; and 5.1.5.lay or ordained representatives of other Christian denominations while in active ministry within the boundaries of the Diocese of Brechin. 5.2. A Priest who has served as Dean of the Diocese and who is appointed an Honorary Canon under 5.1.1. may be known as Dean Emeritus. A Priest who has served as Provost of the Cathedral and who is appointed an Honorary Canon under 5.1.1. may be known as Provost Emeritus. 5.3. Following processes and procedures current in the Province, the Bishop may withdraw the appointment of any Honorary Canonry at any time.

#### The Precentor

The Precentor, unless the Rector himself hold the office, shall be appointed by the Rector and directed by him.

#### Of the Assistant Clergy

The Assistant Clergy shall be appointed by the Provost, or, in case of the Bishop being Provost, by the Rector, subject to the Bishop's consent. They shall obey the Bye-Laws of the Cathedral Church and the directions of the Provost, or, in case of the Bishop being Provost, of the Rector.

[New concept of minor canons, not necessarily in chapter, for other clergy]

## Of the Organist and Choirmaster

The Organist and Choirmaster shall be appointed by the Rector, at salaries fixed by the Vestry, and be removable, subject to an appeal to the Bishop, by the Rector, under whose control they shall perform their duties. The offices may be held by the same person.

#### 7. Minor Canons

- 7.1. Assistant clergy who have been appointed to the Charge of the Cathedral Church of St Paul as provided for in Article 23 of the Constitution may be appointed to be Minor Canons by the Bishop with the agreement of the Provost. They shall serve as assistant clergy in the Cathedral as determined by the Provost in consultation with the Vestry. They shall obey the Bye-Laws of the Cathedral Church and the directions of the Provost.
- 7.2. The title of office for each Minor Canon shall be as determined by the Provost in consultation with the Bishop.
- 7.3. Minor Canons shall cease to hold office on their resignation, retirement or dismissal as assistant clergy of the Charge.

#### Of the Statutory Services

The Statutory Services of the Cathedral church shall be daily Morning and Evening Prayer, according to the Order of the Scottish Book of Common Prayer, and on Sundays and Holy Days, and on appointed days in every week, Celebrations of the Holy Communion. The Cathedral Church shall be open, as far as possible, at all times of the day for private prayer.

#### 8. The Statutory Services

- 8.1. Services in the Cathedral shall be in accordance with Canon 22.
- 8.2. The Cathedral Church shall be open, as far as possible, at all times of the day for private prayer.

#### Of the Bye-Laws

Bye-Laws may be framed by the Chapter, with the approval of the Bishop, in regard to matters needing regulation and not provided for in these Statutes, and such Bye-Laws shall be set out as an appendix to these Statutes.

By-laws which effect the Canons of the Cathedral Church shall be subject to the consideration and approval of the Synod of the Diocese.

#### Of Alterations in the Statutes

To the Chapter belongs the right of initiating alterations in, and additions to, the Statutes; but no alterations to shall be valid until they have been confirmed by the Bishop and the Diocesan Synod, and the Episcopal Synod. No chance in the Statutes inconsistent with the Constitution shall be made unless the Constitution is also altered by those competent to do so.

#### Of the Interpretation of the Statutes

If any questions as to the interpretation of these Statutes, not affecting the right of the Bishop, shall arise, it shall be referred to the Bishop, whose decision, after receiving advice from the Chancellor of the Diocese, shall be final. But if such question concern the rights of the Bishop himself, it shall be referred directly to the Episcopal Synod, whose decision shall be final.

#### 9. The Bye-Laws

- 9.1. Bye-Laws may be framed by the Chapter, with the approval of the Bishop, in regard to matters needing regulation and not provided for in these Statutes, and such Bye-Laws shall be set out as an appendix to these Statutes.
- 9.2. Bye-laws which affect the Canons of the Cathedral Church shall be subject to the consideration and approval of the Synod of the Diocese.

#### 10. Alterations in the Statutes

10.1. To the Chapter belongs the right of initiating alterations in, and additions to, the Statutes; but no alterations or additions shall be valid until they have been confirmed by the Bishop and the Diocesan Synod, and the Episcopal Synod. No change in the Statutes inconsistent with the Constitution shall be made unless the Constitution is also altered by those competent to do so.

## 11. Interpretation of the Statutes

11.1. If any questions as to the interpretation of these Statutes, not affecting the right of the Bishop, shall arise, it shall be referred to the Bishop, whose decision, after receiving advice from the Chancellor of the Diocese, shall be final. But if such question concern the rights of the Bishop, it shall be referred directly to the Episcopal Synod, whose decision shall be final.

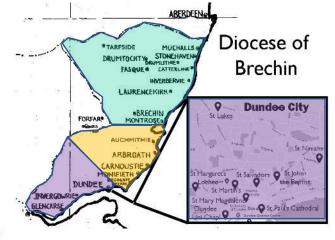

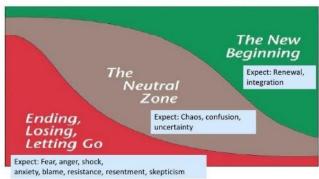

#### **Brechin Diocesan Strategy Overview for Autumn Synod**

Autumn Synod 2019 approved a strategy that we have worked with for four years. A reminder:

<u>Clusters</u>: Desire for charges to have a degree of shared/formal relationship. Network of e.g. treasurers in the north started. Training arranged by Diocese in north, start-up meetings with e.g. desires for events/training in others. Comms gathered by Cluster in lockdown. Issue: the Diocese (i.e. the bishop) was arranging all this – not enough human capacity for Diocese to arrange three separate programmes of events and produces imbalance between charges (some good at doing it, some less so). The pandemic led to Diocesan online events becoming a norm, so the Clusters have become somewhat sidelined.





<u>Transitions</u>: The Diocesan Strategy has focused on releasing funding for charges to be helped employ 'transitional ministers' to work on linkages, future planning, team building. So was a) a way to provide time-limited funding and b) help charges work out what their future might be. This has worked to a large extent: all vacancies were filled and clergy sent on Transitional Ministry training courses. This is also now

being bedded into the wider SEC as a form of ministry and 'change management'. This type of work will continue, with a mixture of fixed short term projects and longer term financial support.

<u>Support</u>: This is mixture of training, courses, social events etc. In the past few years with the pandemic and pressure on ministry has morale improved, held up or become worse? Is the wellbeing of clergy and lay leaders fine? A strand of Diocesan funding/strategy should always be clergy development and support.



## **Revised Diocesan Strategy 2023**

#### 2023 Revision of the Strategy: Brechin as a 'Healthy' Diocese.

Four years on, with work tried in all three areas, but a pandemic and Net Zero programme as major changes in context, we are looking at refining the Diocesan Strategy to refine how the Diocese uses its resources to help all our churches and leaders be healthy in their own context. Three new categories of 'Being Healthy' are proposed:

## **Healthy Churches**

This aspect can be summarised as 'Ministry & Mission' support for All Charges.

Transitional Ministry continues in this category, but we include ALL the churches of the Diocese whether Transitional Ministry projects or not. We want all of our church communities to be supported in their mission and ministry: to be healthy!

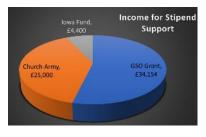


Ongoing financial & governance support, spiritual support maybe via 'Year of Christian Life' activities, encouraging the sharing of courses in prayer, bible study between churches etc. The sharing may reflect the 'Clusters' in arranging inperson gatherings, but clusters would not be an assumed model for grouping church activities.

Relationships with Place for Hope (a conflict transformation charity), GoHealth (a Christian Health & Healing Charity etc.), Church Army and other partners, all of which involve budget decisions, can all be explored under this area. The Diocesan commitment to encouraging and supporting children and youth work is also a key part of being healthy churches.



Support to vacancies and safe recruitment of clergy fall into this area, along with mission planning and audit of charges at times of change.



The Mission and Ministry Support Grants from Edinburgh and other Diocesan/Provincially supported charge funding can all be managed under this heading. We will need to continue to use Diocesan income and reserves for longer term support for ministries. As Transitional Ministry projects end some may require long-term funding, others might change to a more part-time model of paid leadership. We need a framework to make sure this is sustainable in the long term as well as healthy in the short term.

The Chapter would support the Bishop in oversight of all the 'Healthy Churches' work and would take leads on areas of this. Diocesan Council would set budgets for mission and ministry support, primarily supporting the costs of employing clergy in the charges and engaging with mission/ministry partners.

## **Revised Diocesan Strategy 2023**

## **Healthy Environment**

The Scottish Episcopal Church commitment to achieving Net Zero 2030 will need Diocesan support to charges, with Diocesan Council addressing the financial implication of employing staff or assisting with funding for projects and other areas of environmental improvement and energy efficiency for our buildings. Activities are vital to raise awareness, support charges in responding and address the theological aspects of Net Zero and environmental matters.

Staff: It seems likely that the 'Net Zero Champions' for each Diocese will not place a major financial burden on the Diocese, but consultants and other staff costs may be required at Diocesan level in the next few years. This would affect future budgets and allocation of Diocesan reserves.

<u>Diocesan grants</u> are assumed in the Provincial Net Zero plan produced for General Synod 2023, for example for clergy housing insulation improvements. There will also be an urgent need to hold events, liaise with



the Net Zero team and support charges in assessing their carbon footprint and fabric changes. Resources (such as the Net Zero cards shown above) may also require some diocesan input to ensure that all charges can access this excellent material.

Other environmental initiatives: There are many activities and initiatives that charges have been following already for some years. Several congregations are members of 'Eco-Congregation' and work hard on recycling, fair trade and other environmental issues. For the Diocese, tree planting (such as the example shown in lowa), promotion and support for Season of Creation worship, recycling schemes etc. can all be rolled into this area of focus.



This is a very big area for all of the churches in the SEC for the next six years, so this must be a headline task for Council and the Diocese as we set our priorities and our

budgets. For one-off or short-term projects and costs reserves will be used rather than revenue. It is not clear what the financial impact of this work will be on the Diocese or our churches, but the importance of this work makes it vital that it forms part of the next few years of our strategy.

## **Revised Diocesan Strategy 2023**

## **Healthy Leaders**

There are teams of leaders in our churches: the clergy and lay readers and so many others who serve and lead and support our church communities. From headline Diocesan occasions like an institution, shown below, to the day-by-day pastoral care and leadership of the churches, those leaders must be supported.



The Diocese and Bishop take a lead on <u>clergy support</u> through running an annual training programme and social events and other 'team' activities. A budget for clergy to access support/training that they choose themselves is now part of the annual Diocesan budget. A Ministry Review process, currently offered for full-time clergy, has also been launched with members of the Cathedral chapter as reviewers. This process is intended to next be rolled out to the wider group of self-supporting clergy and lay readers. There are also provisions to provide extra help for clergy in the event of illness or other events that impact their wellbeing in their ministry.



<u>Lay training & development</u> is an area where more diocesan work is proposed. We already offer a scheme where the bishop will authorise lay ministries in a church community, under the direction of the local clergy. Lay worship leaders are being trained using Provincial material by their local priest or in local groupings. These worship leaders are forming a vital part of the ongoing liturgical and worshipping life of our churches.

To help the clergy support their lay teams, defining and resourcing a Diocesan scheme for training and support of all authorised ministers is proposed in the next few years: Teaching & Learning for all. We have very skilled and experienced individuals in our church communities and the Chapter, working with the Bishop,

will aim to identify people who can deliver courses and events that will support this development. External training and resources can also be accessed in this way. Some of the ongoing Children and Youth work feed into this plan, with resources and training for those who work with our young people.

The budget implications of this work will not be vast: but Diocesan resource for training, wellbeing and support is vital for the health of all those who lead.

## **RULES OF ORDER OF DIOCESAN SYNOD**

## (Adopted by Synod in 2000)

#### 1. Application

These rules of order shall apply to the proceedings of the Diocesan Synod whether sitting as one body or in separate Houses of Clergy and Laity.

#### 2. The Chair - Powers and Duties

Deference shall at all times be paid to the authority of the Chair. All points of order shall be addressed to the person occupying the Chair, stated briefly and audibly, and raised immediately the perceived irregularity occurs, otherwise the person occupying the Chair shall dis-allow them. Points of order shall not introduce new subject matter. Speeches shall not be allowed on points of order. Where, in the view of the person occupying the Chair, the matter raised does not constitute a point of order, the person occupying the Chair shall rule accordingly. On all points of order the ruling from the Chair shall be final and not open to discussion. When the person occupying the Chair rises to speak, any member of Synod who is addressing the meeting shall sit down.

It shall be the responsibility of the person occupying the Chair to preserve order and secure that members obtain a fair hearing, to decide all matters of order arising at meetings of Synod and to decide, if two or more members rise in their places, which to call to speak. In the event of disorder arising at any meeting of Synod, the meeting may be adjourned by the person occupying the Chair who shall also, then or subsequently, fix a time for its reconvening. Quitting the Chair in such circumstances shall, without further procedure, have the effect of a formal adjournment of the meeting.

#### 3. Order of Debate

Members desiring to speak shall rise in their places. Those called upon to speak shall address the Chair. Speeches shall be directed to the motion or amendment being proposed, seconded or otherwise under discussion or to a question of order. No member shall be allowed to speak more often than once on any subject under discussion, save on a point of order or, with consent of the Chair, to make an explanation, but the mover of a motion shall have a right of reply. A member who is speaking when a question of order is raised shall sit down until the question of order has been decided by the person occupying the Chair.

#### 4. Matters Taken in Private

Synod may decide by a majority of those present and voting that:

- (a) Any business shall be taken in private
- (b) Synod shall go into Committee for the informal discussion of any subject.

#### 5. Adjournment

- (a) Any meeting of Synod may be adjourned to such other place, time or day and hour as may be set by the person occupying the Chair.
- (b) Any meeting of Synod may be adjourned to a later time on the same day and such an adjournment may be made on the direction from the Chair, or failing such direction, on the motion of any member, the vote on which motion, on being seconded, shall without amendment or discussion be taken by a show of voting cards as one House.

## Rules of Order of Brechin Diocesan Synod (2000)

#### 4. Quorum

The Quorum of Synod shall be one half of the voting members of the House of Clergy and of the House of Laity, but no business shall be invalid because transacted without a quorum being present, unless the attention of the Chair has been called to the absence of a quorum. The person occupying the Chair shall then ascertain, in such a way as seems fit, that no quorum is present, and declare the fact. This shall be a responsibility of the person occupying the Chair, whose declaration, whether or not a quorum is present, shall be final. If it has been declared from the Chair that no quorum is present, no business shall be transacted until a quorum is declared from the Chair to be present except:

- (a) the consideration of a motion to adjourn
- (b) such non-contentious business as the meeting, with consent of the person occupying the Chair, sees fit to transact.

If however, a division is challenged on any subject other than on a motion for adjournment, the same shall not be dealt with by the meeting. No motion for adjournment shall be submitted until at least fifteen minutes after the declaration from the Chair that a quorum is not present, except with the consent of the person occupying the Chair.

#### 7. Obstructive or Offensive Conduct

- (a) In the event of any member at any Synod meeting disregarding the authority of the Chair, or being guilty of obstructive or offensive conduct, a motion may thereupon be moved and seconded to suspend such member for the remainder of the sitting. The motion shall be put without discussion.
- (b) The person occupying the Chair shall warn any member of the public who interrupts the proceedings at any meetings. If that member of the public continues the interruption the person occupying the Chair shall order the person concerned to leave the meeting, and not return.

#### 8. Duration of Speeches

The mover of a motion shall not speak for more than ten minutes except with the consent of Synod. All other speakers taking part in the discussion on the motion or amendment shall not normally speak for more than five minutes, subject to the discretion of the person occupying the Chair. The mover of the original motion shall have the right to speak for five minutes in reply, but shall not introduce any new matter into the debate. Thereafter the discussion shall be held closed and the question shall thereupon be put from the Chair.

#### 9. Motions

- (a) Synod shall consider only the following motions:
  - (i) motions which have been included in the Agenda and papers for that meeting
  - (ii) late motions which Synod has agreed to consider (see Rule 10 below)
  - (iii) formal or procedural motions
- (b) All motions and amendments shall be stated, immediately on their being proposed to the meeting, by the mover, before being spoken to. All motions under Rule 9(a) (ii) and all amendments shall be submitted in writing, signed by the mover and seconder and delivered to the Diocesan Secretary immediately on being moved.
- (c) Every amendment shall be relevant to the motion on which it is moved. A motion may be amended by the mover with the consent of the meeting, which consent shall be by the majority of those present and voting. In the case of a motion emanating from a Board or Committee of Synod or a Regional Meeting the mover of that motion shall have the power, unless specifically denied it by the body from which the motion has emanated, to accept the amendment to that motion, thus altering the text of the motion on which Synod is asked to vote.
- (d) A motion or amendment may be withdrawn by the mover with the consent of the seconder of that motion or amendment, but Synod shall have power by simple majority of those present and voting to refuse to allow such withdrawal, in which case the motion shall stand.
- (e) Motions or amendments which are not seconded shall not be discussed or inserted in the minutes.
- (f) If, in the opinions of the person occupying the Chair, more than one motion deals with the same subject matter, only the motion first lodged with the Diocesan Secretary (whether by hand delivery or by post) shall be considered and if, in the opinion of the person occupying the Chair, any motion deals with a matter already under consideration by a Board or Committee, that motion shall not be considered.

## Rules of Order of Brechin Diocesan Synod (2000)

- (g) If a member who has submitted a notice of motion is not present to move the motion, the motion shall fall, unless Synod agrees that another member may move the motion.
- (h) No motion of any kind which involves a grant of money shall be competent unless it is printed in the Agenda with the observations of the Board or Committee within whose budget the grant would fall, with power to the Chair on special occasions to take the sense of the meeting with reference to matters appearing in the Agenda and, if satisfied, to dispense with the necessity of observations by the appropriate Board or Committee. Except as above provided, no motion (other than votes of thanks) shall be entertained unless notice has been given to the Diocesan Secretary in reasonable time to enable it to be entered in the programme of business, or a late motion is accepted in accordance with Canon 50 Resolution 3 (see Rule 10 below).
- (i) The Bishop may veto the discussion of any motion, though otherwise competent, unless at least five voting members of Synod shall express their desire that it should be discussed.

#### 10. Late Motions submitted under Canon 50 Resolution 3

- (a) Notice of late motions should normally be given in writing (to the Diocesan Secretary) before Synod starts.
- (b) The motion shall be in writing, and signed by the mover and seconder, who must be members of Synod qualified to vote.
- (c) The mover of a motion under this Rule shall be given the opportunity to address Synod briefly (maximum of two minutes) as to why Synod should consider the motion at that time before a vote is taken on whether the Motion should be considered.
- (d) Subject to any contrary provision in the Code of Canons, in order for a late motion to be considered by Synod, a majority of those present and voting shall vote in favour of its being considered.

#### 11. Motion: "That the Question be now put"

- (a) The amendment called "The previous question" shall not be allowed.
- (b) It shall be competent for any member who has not spoken on the question before the meeting to move "that the question be now put". On this being seconded, if it seems to the person occupying the Chair that the question before the meeting has been sufficiently discussed, a vote shall be taken, without amendment or discussion. If the motion is carried, the mover of the original motion shall have the right to reply, and the question under discussion shall be put to the meeting. If the motion "that the question be now put" is not carried, a similar motion may be made after every three additional members have spoken.

#### 12. Voting

- (a) After the question on which the vote is to be taken has been announced, and voting has commenced, no member shall be permitted to offer an opinion, or ask a question, except on a point of order, or otherwise interrupt the proceedings until the result of the vote has been intimated.
- (b) Save as otherwise provided, all motions and amendments shall be passed by a majority of the members of Synod present and voting.
- (c) The person occupying the Chair shall have a deliberative but not a casting vote. Whether the matter which is the subject of the vote relates to the appointment of a member of Synod to any particular office or committee, voting shall be by ballot.
- (d) When the question is put to the vote, tellers shall be named from the Chair and shall give in their report on each division taken. Except where otherwise stated in these Rules of Order, the vote may be taken in the first instance on a show of voting cards, the result, in the opinion of the person occupying the Chair, declared therefrom. In all cases of doubt the vote shall be taken counting the cards held up. On any question, if one third of the present and voting members of either House so wish, voting shall be by ballot.
- (e) When voting by Houses, the Houses must meet separately if one third of the present and voting members of either House so wishes. When Synod votes by Houses, the numbers of the vote in each House shall be recorded, and a majority of those present and voting shall be required in each House for the passing of the motion.
- (f) A challenge to the accuracy of the Minutes shall be made by way of an amendment to the motion that the Minutes be approved. Only those members who were present at the previous meeting to which the Minutes relate shall be entitled to vote on the said amendment.

## Rules of Order of Brechin Diocesan Synod (2000)

#### 13. Election, Selection or Appointment of Members of Office

In the case of election, selection or appointment by Synod of a member of Synod or of any other person to any office where the number of candidates nominated exceeds the number of vacancies, the member or person to be elected, selected or appointed as the case may be shall be determined by a vote (or votes) by ballot in (each of) which members will be entitled to vote for as many candidates as there are vacancies. No members may record in the ballot more than one vote for any candidate. The candidate or candidates having the highest number of votes shall be declared duly elected. If there is equality of votes for the last vacancy, this shall be resolved by ballot or by a show of voting cards.

#### 14. Assessor

The Chancellor of the Diocese (whom failing the Registrar, whom failing another person nominated by the Administration Board) shall act as Assessor to the person occupying the Chair. The Assessor shall intervene as Assessor only on the call of the Chair, without prejudice to the right of the Assessor, when a member of Synod to speak and vote as such.

#### 15. Suspension of Rules

The application of any of these Rules of Order may be temporarily suspended or amended by a majority amounting to two-thirds of those present and voting. Voting shall be in one House.

#### CONSTITUTION FOR THE DIOCESAN SYNOD OF THE DIOCESE OF BRECHIN

(Scottish Charity No SCO16813)

Approved by Diocesan Synod, 7 March 2020.

#### **Diocesan Synod**

- 1(a) There shall be a Diocesan Synod in which is vested the functions, powers and duties set out in Canon 50 Of Diocesan Synods and in Sections 6.61 and 7 of the Digest of Resolutions of the General Synod 1997 and such other relevant Resolutions that General Synod may pass.
- 1(b) The Diocesan Synod's Boards and Committees shall comprise those listed in Articles 7 to 9 inclusive, hereof.

#### Membership

- 2 The Diocesan Synod shall consist of the Bishop, all instituted, licensed and commissioned clergy of the diocese, the diocesan officials as specified in Canon 61, and the lay members specified in Section 3 below. The Diocesan Chancellor or Registrar may also attend as assessor to the Synod.
- 3(a) The lay members of the Synod shall consist of a lay representative for each congregation within the Diocese, the lay members of General Synod elected by the Diocesan Synod under Canon 52 Section 5, the alternate members of General Synod under canon 52 Section 7, a lay member of the Diocesan Council ex officio and such additional lay members as elected by the Diocesan Synod. General Synod members comprise those lay representatives or alternates elected from each diocese. In addition, other members of the General Synod through membership of provincial boards and committees are for their period of office members of the Diocesan Synod.
- 3(b) Alternate Lay Representatives, Lay Readers, Church Army Evangelists, members of Religious Orders and others working in the Diocese shall be invited to participate fully in the proceedings of the Diocesan Synod, save in the matter of voting.

#### Meetings

4. In accordance with Canon 50 Section 8 the Bishop shall preside. In the absence of the Bishop, the Dean of the Diocese shall preside, but should the Dean also be absent the meeting shall appoint one of its own members.

#### **Officials**

5. The Synod shall appoint a Treasurer, a Secretary and an Auditor/Independent Examiner whose appointment shall not be for a longer period than until the next meeting.

#### 6. Trustees

The Diocesan Council shall be the Charity Trustees for the diocese.

The Property Trustees shall be the Bishop, the Dean, the Chancellor and the Registrar ex officio.

#### **Boards and Committees**

- 7(a) The Diocesan Council shall be responsible for acting in an emergency on behalf of the Synod.
- 7(b) in any emergency in the absence of the Bishop the Dean shall chair; if neither is present the Council shall appoint one of its members to chair the meeting.

## **Constitution of Brechin Diocesan Synod (2020)**

- 8(a) The Diocesan Council shall administer the strategic direction and life of the diocese on behalf of the Diocesan Synod in all matters of mission and ministry, finance and property, and such matters sent to the diocese by the General Synod. For avoidance of doubt the Diocesan Council shall be responsible for the appointment of salaried staff employed by the Diocese and their terms of employment.
- 8(b) Membership of the Diocesan Council shall be: the Bishop, who shall act as chair; the Dean, Diocesan Treasurer, Diocesan Secretary, four Lay Members elected by the House of Laity and four Clergy members elected by the House of Clergy.

The Diocesan Secretary shall act as Secretary to the Diocesan Council. The Diocesan Council shall have the power to co-opt for any vacancies that may arise between Synods whose term shall only continue until the next Synod.

Each member of the Diocesan Council shall have one vote.

- 8(c) The Diocesan Council shall have the power to appoint pendant or ad hoc committees or working groups.
- 9(a) There shall be a Diocesan Buildings Committee, reporting to the Diocesan Council, set up in accordance with Canon 35 and Canon50(9) The membership shall be the Dean, the Diocesan Secretary, the Diocesan Archivist and include other persons with professional expertise in architecture, ecclesiastical artefacts and liturgy to consider and determine proposals relating to all changes to the fabric of Church Buildings as provided under Canon 35 (1). In addition Synod shall elect up to six members to serve for a term of three years. At least one of the elected members will be a member of the House of Clergy.
- 9(b) The central function of the Diocesan Buildings Committee is to fulfil the requirements of Canon 35. In addition, the committee will provide information, advice and support to the Diocese and to individual charges relating to changes to the fabric or buildings including visits or inspections which are unrelated to Canon 35 applications.

#### **Members and Conveners**

10. Unless otherwise specified in this Constitution, elected members of the Diocesan Council shall serve a term of three years and may be re-elected or reappointed provided that no member shall serve for a continuous period of more than six years. No member on ceasing to be a member shall be eligible for re-election until after an interval of at least one year. In the event of any vacancy, appointments shall be made by the Diocesan Synod at its Annual Meeting after nominations have been invited from members. Casual vacancies may be filled by the Council until the next Annual Meeting of Synod when an appointment shall be made for a new three year period.

#### Quorum

- 11. At meetings of the Diocesan Synod, the quorum shall be one half of the number of Clerical and the number of lay members entitled to vote, rounded up to the nearest whole number.
- 12. At meetings of the Diocesan Council, and the Diocesan Buildings Committee, the quorum shall be one third of the total membership, rounded up to the nearest whole number.

## Amendment of Constitution or adoption of new Constitution

14. It is competent for this Constitution to be amended or a new Constitution adopted by a simple majority of those present and voting at a meeting of the Diocesan Synod. Proposals for changes to the Constitution must be submitted for consideration to the Diocesan Council, whose comments shall be reported to Synod.

#### **Review**

15. Notwithstanding the power of the Diocesan Synod to amend its constitution or to adopt a new Constitution at a duly constituted meeting thereof, the Constitution of the Diocesan Synod shall be reviewed

by the Diocesan Council for the next Synod and at the end of each five year period thereafter, and any recommendations for alteration brought to the Diocesan Synod.
